

SUMMARY ANNUAL REPORT

For LOCKE LORD, LLP MEDICAL CARE REIMBURSEMENT PLAN

This is a summary of the annual report of the LOCKE LORD, LLP MEDICAL CARE REIMBURSEMENT PLAN, EIN 74-1164324, Plan No. 503, for period 01/01/2020 through 12/31/2020. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

LOCKE LORD LLP has committed itself to pay certain self-funded Medical and Short-term Disability claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with ACE AMERICAN INSURANCE COMPANY, DELTA DENTAL INSURANCE COMPANY, JOHN HANCOCK LIFE INSURANCE COMPANY, VISION SERVICE PLAN, GENWORTH LIFE INSURANCE COMPANY, PROVIDENT LIFE AND ACCIDENT INSURANCE COMPANY, and STANDARD INSURANCE COMPANY to pay Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Long Term Care, and Business Travel Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2020 were \$3,580,690.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2020, the premiums paid under such "experience-rated" contracts were \$1,944,168 and the total of all benefit claims paid under these contracts during the plan year was \$1,513,559.
